Stallion Enrollment Form**

I, _____ (owner/agent) enroll the stallion, _____

Registration # _____ 2012 Stallion Fee: \$ _____ Breed: _____ into the WCHA Breeder's Futurity for 2012 and agree to the following Terms and Conditions:

1. This stallion enrollment form must be mailed and postmarked on or before April 1, 2012.
2. **A copy of the stallion's registration paper must accompany this form.**
3. The stallion owner must be a current WCHA member.
4. The enrollment fee must be equal to the advertised stud fee of said stallion in 2012, or \$600.00, **whichever is greater.** If standing at Private Treaty the enrollment fee is the highest amount collected from any mare in 2011, or \$600.00, whichever is greater.
5. No mare(s) will be bred prior to February 1 of any year stallion is enrolled in the WCHA Breeder's Futurity program.
6. Once enrolled in the program, all stallions are automatically enrolled for all subsequent years until stallion owner notifies the WCHA that he/she no longer wishes to participate.
7. The WCHA will retain \$75.00 of each stallion's fee to help offset advertising and operating costs.
8. After the enrollment fee is fully paid all weanlings and yearlings sired by the above stallion are eligible for competition in the WCHA Breeder's Championship Futurity in 2012.
9. All Appaloosa, Buckskin, Dun, Paint, Palomino and Quarter Horse stallions are eligible for the WCHA Futurity program.
10. 50% of each Paint and Appaloosa stallion's nomination fee will be allocated to the Paint and Appaloosa futurity classes, the remaining 50% goes into the open and non-pro purses. Offspring of colored stallions are eligible to show in the open, non-pro and colored futurity classes. AQHA and APHA Stallions that have dual registration papers will have nomination fees split 50-50 with the Open division.
11. After April 1, late enrollments into the program will be accepted at double the advertised stud fee if postmarked on or before **July 1, 2012. No stallion nominations will be accepted for 2012 after this date.**
12. WCHA Futurity Committee reserves the right to distribute stallion nomination funds and add or subtract various classes.
13. No Refunds. Violation of any rule or inaccurate amount of the stud fee nomination will result in immediate suspension from the program with all fees non-refundable.

 - ✓ Check # 1 in the amount of one half (1/2) of nomination fee. Must be received on or before April 1, 2012.

 - ✓ Check # 3 (if needed) for WCHA membership of \$50.00 for stallion owner, separate check payable to WCHA.
