\* Limited Open as defined in WCHA's rules and regulations is any person who is a WCHA member and who has not been an Open Quarter Horse Congress Halter Champion or an Open Halter World or Reserve World Champion in AQHA or APHA in the previous five (5) years. Any AQHA, APHA, and WCHA carded judges are ineligible for this level of competition.
