 - Motion to allow Klover and Falcon to use any portion of savings as they determined necessary to cover expenses and enhance purses. Seconded
 - Motion Carried Unanimously
 - Klover and Falcon reiterated to the Executive Committee they have final approval of disbursements after payouts are calculated.
