RULES:

1. EXHIBITORS OF 7 YEARS AND YOUNGER
2. EACH EXHIBITOR MUST HAVE 2 PEOPLE TO ASSIST, ONE PERSON ON EACH SIDE OF EXHIBITOR.
3. HORSES MUST BE ONE YEAR OR OLDER, NO WEANLINGS. HORSES CAN BE "BORROWED".
4. NO ENTRY FEE, ALL EXHIBITORS WILL RECEIVE A PRIZE FOR COMPETITION
5. NO CROSS ENTRY: If exhibitor competes in Joes Kansas City Bar B Que Youth Stakes they cannot show in this Pee Wee Halter Class.
6. ABSOLUTELY NO EXHIBITORS ROLLING-PLAYING-SITTING ON THE DIRT, BEING DISRUPTIVE TO THE OTHER COMPETITORS OR ANY BEHAVIOR THAT WOULD BE UN-SAFE TO THEMSELVES OR OTHER COMPETITORS. **This will warrant automatic removal from the arena and we ask the parents to remove their child from the arena immediately.**
7. ALL EXHIBITORS MUST WEAR A HAT
8. ALL EXHIBITORS MUST "WANT TO BE COMPETING", IF NOT PLEASE LEAVE THE ARENA.
9. ALL PARENTS MUST SUBMIT ENTRY FORM
10. ALL PARENTS MUST SUBMIT SIGNED RELEASE FORM PRIOR TO COMPETITION

REQUEST TO PARENTS: IF YOUR CHILD DOES NOT WANT TO BE IN THE CLASS PLEASE DON'T PUT THEM IN THE CLASS, THE ABOVE RULES ARE PUT IN PLACE TO COMPLY WITH LIABILITY INSURANCE POLICIES OF WCHA AND APHA. IF WE ARE TO CONTINUE WITH THIS CLASS PARENTS NEED TO COMPLY WITH RULES & CONDITIONS.

FURTHERMORE: PLEASE DO NOT SEND YOUR CHILD INTO THE CLASS WITH A HORSE THAT IS NOT SAFE OR IS UNPREDICTABLE IN AN ARENA ENVIRONMENT.

First Place Prize Criteria

A first place prize will be awarded to the exhibitor who demonstrates the best horsemanship skills by showing their horse proficiently and maintaining control throughout the competition. Judging will focus on the exhibitor's ability to present their horse confidently and execute proper handling techniques.



Release of Liability Waiver

In consideration of the risk of injury associated with participating in all activities organized by the World Conformation Horse Association (WCHA), including the Pee Wee Halter Class as an exhibition class at the WCHA Breeder's Championship Show, and as a condition for the right to take part in these events, I hereby, for myself and on behalf of my heirs, administrators, or personal representatives, knowingly and voluntarily agree to this waiver and release of liability. I waive all rights, claims, or causes of action of any kind that may arise from my or my family's participation in WCHA activities. Furthermore, I release and forever discharge WCHA, whose headquarters are located at 235 St Andrews Drive, Calhoun, LA, along with their affiliates, managers, members, agents, staff, volunteers, representatives, and officers from any physical or psychological injury—including, but not limited to, illness, paralysis, death, damages, economic, or emotional loss—that I or my family members may suffer as a direct result of participating in the aforementioned activities.

I acknowledge that I and/or my family members are voluntarily participating in these activities and am fully aware that we do so entirely at our own risk. I understand the risks associated with participating in these events, which may include, but are not limited to, physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability (including paralysis), economic or emotional loss, and death. I am aware that such injuries or outcomes may result from my own or others' negligence, conditions related to travel, or the condition of the event location. Despite these risks, I accept all related risks, whether known or unknown to me, connected to my participation in any event hosted by WCHA, including travel to, from, and during these activities.

I agree to indemnify and hold harmless WCHA/APHA from all claims, suits, actions of any kind for liability, damages, compensation, or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs if litigation arises from any claims made by me or anyone acting on my behalf. I acknowledge that WCHA and its directors, officers, volunteers, and representatives are not responsible for errors, omissions, acts, or failures to act by any party or entity conducting a specific event or activity on behalf of WCHA.

I confirm that I have carefully read this "Waiver and Release" and fully understand it is a release of liability. I expressly agree to release and discharge the World Conformation Horse Association, the American Paint Horse Association, and all their affiliates, managers, agents, attorneys, volunteers, sponsors, representatives, officers, and directors from all claims or causes of action. I voluntarily give up or waive any right I might otherwise have to bring legal action against WCHA and the entities for personal injury or property damage. To the extent permitted by law, this release also covers negligence on the part of WCHA, its agents, volunteers, officers, directors, and employees.

If I, OR A FAMILY MEMBER, require medical care or treatment, I agree to be financially responsible for any and all costs incurred as a result of such treatment. I understand that I should maintain my own health insurance coverage.

I, the undersigned participant, affirm that I am at least 18 years of age and am freely signing this agreement. I certify that I agree to the terms and conditions of this Release of Liability, fully understand its content, and acknowledge that this release cannot be modified orally. I am aware that this is a release of liability and a contract that I am signing of my own free will.
