- 1. The stallion owner must be a current WCHA member. Membership Fee is due at time of enrollment.
2. AQHA, APHA, ApHC, registered Stallions are eligible for the WCHA Futurity program.
3. BREAKING NEWS: The stallion enrollment fee for the WCHA Breeder's Futurity has been reduced to a flat rate of \$1000 for all stallions including those standing at private treaty or those deceased.
4. After the enrollment fee is fully paid ALL Offspring sired by the above stallion are eligible for competition in the WCHA Breeder's Championship Futurity in 2020 if foal nomination fees are paid prior to competition.
5. Fees are used to help offset futurity expenses, including paybacks, as well as WCHA retains 10% of the gross revenues to assist with defraying expenses associated with operating and supporting the sponsoring parent organization.
6. WCHA reserves the right to determine all rules and regulations and payouts governing the futurity.
7. No Refunds. Violation of any rule will result in immediate and permanent suspension from the program with all fees non-refundable.
