### Rules and Conditions:

1. The stallion enrollment fee is a Flat Rate of \$1,000 if paid in full by June 1<sup>st</sup>, late fees of \$100 per month apply thereafter. If using a payment plan a post-dated check must be included or credit card information provided.
2. **Deceased Rate:** \$750 per annual enrollment, all offspring regardless of age are eligible for competition.
3. AQHA, APHA, ApHC, registered Stallions are eligible for the WCHA Futurity program.
4. After the enrollment fee is fully paid **All Offspring, Any Breed, All Ages**, sired by the above named stallion are eligible for competition within the WCHA Breeder's Championship Futurity in **2025**.
5. Offspring of enrolled stallions must also be nominated with WCHA.
6. Stallions Must Be Enrolled Each Year For Offspring Of Any Age To Maintain Eligibility For Competition Within WCHA.
7. Fees are used for class paybacks, awards and futurity expenses, 10% of the gross revenues to assist with defraying expenses associated with operating and supporting the association in putting forth this futurity.
8. **Violation of any rule will result in immediate and permanent suspension from the program with all fees non-refundable, when enrolling your stallion all stallion owners agree no mares will be bred prior to February 1<sup>st</sup>.**

**WCHA reserves the right to determine all rules and regulations and payouts governing the futurity. No Refunds. Violation of any rule will result in immediate and permanent suspension from the program with all fees non-refundable.**
