To Be Eligible For Competition Into "BIG MONEY FUTURITY" Horses MUST First Be Nominated Prior To Entering Competition.  
Horses Must Be Nominated Each Year To Remain Eligible, If Not There Is A "Catch Up" Nomination Option At Higher Fees In 2026 & Beyond

*Pay Just One Fee For Eligibility Into All Big Money Events Based On Date You Send, If You Do Not Intend To Compete With This Horse In 2026 You Are Still Required To Nominate or Pay Catch Up Fee In 2027:*

## Weanlings:

- \$100 "EARLY BIRD" Nomination Fee If Paid Within 60 Days of Foaling Date – No Exceptions
- \$150 – Flat Fee After 60 Days Of Foaling, if you do not intend to compete in 2024 it is cheaper to nominate by December 31 or pay catch up fees the following year

## Yearlings & Older Horses

- \$100 - "Early Bird Rate" – For those horses who were nominated in 2025, If Paid By March 15<sup>th</sup>.
- \$150 - After March 15<sup>th</sup> to Dec 31<sup>st</sup> – For those horses who were nominated in 2025.
- Flat Rate "Catch Up Fee" for any horse who was NOT nominated into Big Money in 2025 = \$200, **no other fees for 2025 is required except for a flat rate color nomination if horse qualifies.**

## Color Nominations:

An additional nomination fee is required to be eligible for color classes within all Big Money Futurity Classes. All horses with APHA, ApHC, PHBA, ABRA or ARHA registry are eligible for color divisions.

- \$50 – Flat Rate Color Nomination Fee For All Horses Regardless of Age, Color Fee Must Be Paid Same Time As Regular Nomination. **No Catch Up Fee Is Required for Color Nomination if horse was not nominated in 2025 !!**
